Health & Safety Policy



Management in Avanti Wind Systems (AWS), as a company of Alimak Group, has an ongoing commitment to strengthen the health and safety culture at work throughout the Group and to make sure that employees always ensure and promote safe behavior at work.

Avanti Management must provide all necessary resources to:

- Ensure a safe and healthy working environment for its employees, contractors, and visitors guaranteeing legal compliance.
- Promote training of employees in relation to hazards present in their job activities, thereby informing them and encouraging compliance with safety regulations.
- Promote consultation and participation of workers and their representatives
- Protect facilities and equipment to ensure adequate safe and healthy working conditions for the prevention of work-related injury and ill health.
- Be aware of safety hazards to eliminate them and OH&S risks to reduce them to keep all employees safe.
- Foster a Group safety culture through awareness, participation, communication, safe behaviour and involvement of employees and external service providers in matters of occupational health and safety.
- Provides a framework for setting the OH&S objectives

Safety is integrated in all quality aspects of Avanti and Alimak Group products and services.

This Health & Safety Policy applies to all Wind Division units in their different geographies.

The guidelines for Occupational Health & Safety Practice at Avanti are the following:

- 1) Safety (hygiene & health at work) is an integral part of Avanti' activities being evident in all decisions.
- 2) **Safety** is an attitude and willingness based on respect and fulfillment of procedures and instructions. Contributing to improving **Safety** is an ongoing development.
- 3) Safety is a natural part of Management's responsibility such as:
 - Ensuring implementation of legal and other requirements
 - Showing a visible and permanent personal commitment
 - · Promoting training and information to its employees
 - Controlling the work environment
- 4) At all times and in any situation, the local units takes responsibility and manages his Occupational Health & Safety activities with the ultimate objective of "zero accidents".

- 5) **Safety** at work is achieved through a systematic risk analysis and assessment involving employees, contractors, and visitors with the consideration of all activities performed by above mentioned parties.
- 6) The main tools in Avanti and in the whole Alimak group for the continuous improvement of prevention of accidents and work-related illness:
 - Investigation and analysis of accidents and incidents
 - Safety observations
 - Measurable OH&S objectives and targets
- 7) Keep safety procedures and instructions updated according to existing risks and relevant local legal and other requirements.
- 8) No situation or urgency of any service activity can justify endangering any employee's safety.
